ESTABLISHED BY:	Resolution 2023-068 of the Tracy City Council
MEMBERSHIP, QUALIFICATIONS AND RESIDENCY REQUIREMENTS	Seven (7) – The membership shall consist of five (5) adult residents and two (2) youth residents (High school students up to and including their senior graduating year). Appointed by City Council. Members shall be residents of the City of Tracy who meet the residency requirements as outlined in Resolution 2004-152.
TERM	Each adult member shall serve a four-year term and each high school member shall serve a one-year term.
COMPENSATION	None
DUTIES	<ol style="list-style-type: none"><li>1. Develop comprehensive, integrated environmental policies for implementation by the City to protect and enhance the City's air, water, and land.</li><li>2. The Commission is limited to performing tasks enumerated in its enabling resolution, the bylaws, and otherwise delegated to it by City Council. The Commission is responsible to the City Council and is charged with:<ul style="list-style-type: none"><li>• Acting as an advocate for protecting, preserving, and enhancing the environment as it relates to issues under consideration by the City Council and Planning Commission.</li><li>• Serving in an advisory role to the City Council and all Boards and Commissions, as may be requested from time to time, on environmental and sustainability policy issues. The Commission may recommend new ordinances, amendments to existing ordinances, and other actions it deems appropriate.</li><li>• Providing a means for promoting discussion and education on issues related to the environment and sustainability.</li><li>• Preparing an annual report to be presented to the City Council which includes, but is not limited to these items:<ul style="list-style-type: none"><li>➢ Climate, Air and Energy</li><li>➢ Stormwater</li><li>➢ Urban Forest and Biodiversity</li><li>➢ Consumption and Waste; including Recycling</li><li>➢ Water and Conservation Resource</li><li>➢ Protection and Preservation</li></ul></li></ul></li></ol>

ESTABLISHED BY:	Ordinance 1223
MEMBERSHIP, QUALIFICATIONS AND RESIDENCY REQUIREMENTS	Five members appointed by City Council. Members shall be residents of the City of Tracy who meet the residency requirements as outlined in Resolution 2004-152.
TERM	The Oversight Committee commenced on March 1, 2011. Of the five members of the Committee first appointed, three shall be appointed for a three-year term and two shall be appointed for a two year term. Subsequent appointments to the Oversight Committee shall be until the reporting period for the last one-half cent sales tax collected pursuant to Measure V. No member of the committee shall serve more than two consecutive terms
COMPENSATION	None
DUTIES	<p>As set forth in the Measure V Residents' Oversight Committee Bylaws adopted by Resolution 2011-019, the committee's roles and responsibilities will include the following:</p> <ul style="list-style-type: none"><li>• To serve in an advisory-only capacity to the City Council.</li><li>• To provide oversight of the revenues and expenses pertaining to the portion of the sales tax generated by Measure V.</li><li>• To review the annual independent financial audit of the City performed by an independent auditor on sections pertaining to the revenue and expenses related to the portion of the sales tax generated by Measure V.</li></ul> <p>To review other City financial reports pertaining to the revenue generated by and expenses related to the portion of the sales tax generated by Measure V revenue and expenses.</p> <ul style="list-style-type: none"><li>• Providing Council with an annual written report.</li><li>• Additional reports to Council can be provided to Council at the Committee's and/or Council's discretion (all reports must be in writing and agendaized pursuant to the Brown Act).</li></ul>

ESTABLISHED BY:	Tracy Municipal Code, Chapter 7.16
MEMBERSHIP, QUALIFICATIONS AND RESIDENCY REQUIREMENTS:	Five members, five of whom shall be appointed by City Council, each term to commence the first day of January. The members shall be citizens, but not City officials or employees and must reside within the Tracy city limits. One member shall be appointed by the Tracy Unified School District; said term to commence the first day of January.
TERM:	Four years. Vacancies occurring during a term shall be filled for the unexpired period of term.
COMPENSATION:	\$50 per meeting, not to exceed \$100 per month
DUTIES:	Establish rules and regulations governing the conduct of recreation programs, protection of property, and activities of persons in all parks; hold public hearings on recreation programming and facility usage; advise the City Council on the subject of recreation and facility master planning and development; review grants.

## PLANNING COMMISSION

ESTABLISHED BY:	State of California Statutes; Tracy Municipal Code, Chapter 10.04
MEMBERSHIP, QUALIFICATIONS AND RESIDENCY REQUIREMENTS:	The City of Tracy Planning Commission shall consist of five members appointed by the City Council. The members shall be residents, not officials or employees of the City.
TERM:	Four-year terms, at the pleasure of the City Council.
COMPENSATION:	\$50 per meeting, not to exceed \$150 per month, actual and necessary expenses for out-of-town meetings and conferences.
DUTIES:	Prepare and recommend adoption, amendment or repeal of the City's General Plan; make recommendations to the proper City officials regarding maps or plats of land subdivision in accordance with State Subdivision Map Act and City Code; hold hearings on planning and zoning matters per State and City laws; advise and recommend regarding acquisition, use, or disposition of City-owned property.

TERM:	Four years. Vacancies occurring during a term shall be filled for the unexpired period of term.
COMPENSATION:	\$50 per meeting, not to exceed \$100 per month.
DUTIES:	Encourage, promote and stimulate the growth of broad based arts and cultural programs in the community. Pursue and solicit private, regional, state and federal funding support for arts programs and facilities development. Strive to maintain an active and broad based representation of community arts interests on the Commission. Perform other arts-related duties and functions as the City Council may direct.

# TRANSPORTATION ADVISORY COMMISSION

ESTABLISHED BY: Resolution 2007-120

MEMBERSHIP, QUALIFICATIONS AND RESIDENCY REQUIREMENTS Five members, appointed by the City Council. Members shall have a desirable background and expertise in specified areas of public transportation, such as the airport, buses, rail or bikes. Members shall be residents of the City of Tracy.

TERM: Four years. Vacancies occurring during a term shall be filled for the unexpired period of term.

COMPENSATION: Fifty Dollars (\$50) a meeting, not to exceed One Hundred Dollars (\$100) per month.

DUTIES:

- Address various public transportation issues
- Review City-wide
- Advise on service levels and routes
- Recommend rules and procedures governing public transportation service programs, equipment and facilities considering regulatory guidelines, service improvements, coordination, efficiencies, protection of property, service improvements and activities of persons utilizing transportation service and facilities
- Recommend rates, fares, user fees, charges and deposits for the use of transportation service programs and facilities
- Review surveys and facilitate public input on public transportation programming and facility usage
- Identify transportation infrastructure needs and recommend allocation of funds for capital expenditures related to transportation improvements
- Review grants, budgets, facility developments and designs, and transportation programs
- Advise the Council on the subject of comprehensive Citywide public transportation master planning and development
- Review, monitor, and make long-range recommendations concerning public transportation and connectivity sections of related environmental impact reports of development projects during the public review period and other similar documents
- Recommend and promote marketing strategies for community outreach programs in order to strengthen the transportation image, increase usage, and integrate its role within the community
- Recommend to the Council, after public input, the adoption, amendment or repeal of ordinances, resolutions, or requirements pertaining to public transportation within the City.

## YOUTH ADVISORY COMMISSION

ESTABLISHED BY:	City Council Resolution 98-191, June 16, 1998
MEMBERSHIP, QUALIFICATIONS AND RESIDENCY REQUIREMENTS:	Eight youths aged 13-19 years attending school in the city limits; three youths aged 13-19 years residing in the Tracy District area; three adult advisors and one Parks and Community Services Department staff person
TERM:	Initially, five commissioners shall serve a one-year term, six commissioners shall serve a two-year term. Thereafter, each commissioner shall serve a two-year term and may serve no more than two terms for a total of four years. Two adult members shall serve a two-year term, initially, and one adult shall serve a one-year term. Thereafter, each adult shall serve a two-year term and may serve no more than two consecutive terms for a total of four years.

DUTIES:	To provide youth with an opportunity to make recommendations to staff, the Parks and Community Services Commission, City Council and other groups on matters related to the welfare of youth in Tracy

## BOARD OF APPEALS

ESTABLISHED BY:	Tracy Municipal Code, Chapter 9.44
MEMBERSHIP, QUALIFICATIONS AND RESIDENCY REQUIREMENTS:	Five members appointed by the Mayor with advice and consent of the Council. The Board shall consist of members who are qualified by experience and training to pass on matters pertaining to building construction (such as licensed Contractors, engineers and architects). A member shall be neither an elected officer nor an employee of the City, but may be a member of another City board or commission. A member need not be a resident of the City.
TERM:	The term of office for each member shall be four (4) years with staggered terms. Vacancies occurring during a term shall be filled for the unexpired period of such term. Members shall serve at the pleasure of the Council and may be removed from office without cause upon an affirmative vote of the majority of the Council.
COMPENSATION:	None
DUTIES:	<p>To hear appeals of administrative decisions regarding use of alternate materials, interpretations pertaining to enforcement of any provisions of the Building, Plumbing, Mechanical, Electrical, Fire Codes and related regulations listed in TMC Section 9.44.010; and</p> <p>To hear appeals of administrative decisions in the application of the Uniform Housing Code, the Uniform Code for the Abatement of Dangerous Buildings, and related sections of this Code in actions declaring certain building structures or conditions therein substandard, unsanitary, or hazardous and requiring their consideration, rehabilitation, reconstruction, correction, or abatement as applicable.</p>
