NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that the City Council of the City of Tracy will conduct a Public Hearing during its regular City Council meeting on **Tuesday, January 20, 2026, at 7:00 p.m.**, or as soon thereafter as possible, at Tracy City Hall, Council Chambers, 333 Civic Center Plaza, Tracy, California, 95376. During this Public Hearing, the City Council will consider and take action on:

- A) A RESOLUTION CREATING CITY COUNCIL ELECTION DISTRICTS AND THEIR RESPECTIVE BOUNDARIES WITHIN THE TERRITORY OF THE CITY OF TRACY AS PROVIDED BY SECTIONS 34886 AND 34871 OF THE CALIFORNIA GOVERNMENT CODE; AND**
- B) WAIVING THE FIRST READING BY SUBSTITUTION OF TITLE AND INTRODUCING AN ORDINANCE (1) AMENDING THE TRACY MUNICIPAL CODE TO ADD AN ELECTIONS CHAPTER (CHAPTER 2.01) AND SUBSECTIONS ESTABLISHING BY-DISTRICT ELECTIONS FOR CITY COUNCIL MEMBERS, EXCLUDING THE MAYOR (SECTION 2.01.010), CITY COUNCIL ELECTION DISTRICTS (SECTION 2.01.020), AND THE SEQUENCE OF ELECTIONS FOR CITY COUNCIL MEMBERS ELECTED BY DISTRICT (SECTION 2.01.030); AND (2) RELOCATING THE TERM LIMITS SECTION OF THE TRACY MUNICIPAL CODE TO THE ELECTIONS CHAPTER OF THE TRACY MUNICIPAL CODE (FROM SECTION 2.04.040 TO SECTION 2.01.040)**
